

# CO CURRICULAR ACTIVITY – 2

DEBATE (ISDS FORMAT)

Grade 9-12 [August 2023]

Theme: Patriotism or Nationalism

Date: 19<sup>th</sup> August 2023

Duration:15 minutes

Grade Levels: 9 to12

## **INTRODUCTION:**

The Debate English Club organized a thought-provoking activity for students in grades 9 to 12, centered around the topic "**Difference between Nationalism and Patriotism - Which is Better for Nation Building?**" This activity aimed to encourage critical thinking, research skills, public speaking abilities, and a deeper understanding of the concepts of nationalism and patriotism. By engaging in a structured debate, participants were able to explore the nuances of these concepts and their implications for nation-building.

# **ACTIVITY DETAILS:**

#### 1. Preparation Phase:

- *Research*: Participants were given time to research and gather information about the definitions, historical contexts, and implications of both nationalism and patriotism.

#### 2. DEBATE STRUCTURE:

- Opening Statements: Each group started the debate with an opening statement that defined their assigned concept, highlighted its key attributes, and outlined its potential positive impact on nation-building.
- *Rebuttals*: After the opening statements, participants engaged in a series of rebuttals, where they refuted the opposing group's arguments using evidence and logical reasoning.
- *Cross-Examination*: Following the rebuttals, participants had the opportunity to question and cross-examine members of the opposing team to probe their arguments further.
- *Closing Statements:* The debate concluded with closing statements from both groups, summarizing their key points and reinforcing their stance on the topic.

#### **3. AUDIENCE INVOLVEMENT:**

- *Question and Answer Session*: After the formal debate, the audience had the chance to ask questions to both groups, encouraging participants to think on their feet and respond to inquiries from their peers.
- Audience Poll: To engage the entire audience, a poll was conducted before and after the debate to gauge their opinions on which concept they believed was better for nation-building.

# **LEARNING OUTCOMES:**

- *Critical Thinking*: Participants learned to critically evaluate the concepts of nationalism and patriotism, analyse their merits, and discern their implications for nation-building.
- *Research Skills:* The research phase allowed students to delve into historical, social, and political contexts, enhancing their ability to gather and synthesize information.
- *Public Speaking and Communication*: Engaging in formal debates sharpened participants' public speaking skills, enabling them to present their arguments confidently and persuasively.
- Logical Reasoning: Students honed their skills in constructing logical arguments, anticipating counterarguments, and providing evidence-based responses.
- Understanding Different Perspectives: By taking on opposing roles, participants developed empathy and a better understanding of differing viewpoints, fostering tolerance and open-mindedness.
- Audience Engagement: The Q&A session and audience poll promoted engagement and participation among the attendees, encouraging active thinking and dialogue.

### **CONCLUSION:**
